After the Pledge of Allegiance, Vice Chairman Baronich called the meeting to order at 7:00pm

The first Certificate of Appropriateness before the board tonight came from Kenneth Winter regarding 78 E. Main Street. Mr. Winter is looking to repair/replace any damaged siding and then paint the entire house and garage.

The base color will be a barn red and the trim will be tan and brown. Mr. Winter presented the samples to the board.

After some discussion and review of this application, Acting Chairman John Baronich asked for a motion.

Mike Wolniewicz made the motion to approve as presented, seconded by Kelly Baker. All in favor, none opposed.

The next Certificates of Appropriateness before the board came from Seth Wochensky with the Springville Center for the Arts. The Springville Center for the Arts is looking to do Mural Projects throughout the Village of Springville. The addresses being discussed today are 35 E. Main St., 52 E. Main St., 53 E. Main St., 85 E. Main St. and 27 Franklin St.

All of the Murals will involve using poly-tab to paste imagery on the structures. Poly-tab is also known as mural cloth is a mix between canvas and wallpaper. It is incredibly sturdy, resilient and can be printed on. The murals will be considered permanent but can be painted over. All the murals will contain photos and words from the Springville Journal.

After some discussion and review of this applications, Acting Chairman John Baronich asked for a motion.

Mike Wolniewicz made the motion to approve the Certificate of Appropriateness for 35 E. Main St., 52 E. Main St., 53 E. Main St. and 27 Franklin St. as presented, seconded by Kelly Baker. All in favor, none opposed.

Mike Wolniewicz made the motion to approve the Certificate of Appropriateness for 85 E. Main Street with the STIPULATION that the Village of Springville, who is the owner of the Blocks, gives permission. Seconded by Don Orton. All in favor, none opposed.
